## Management's Assertion and Report on the Use of Proceeds

NW Natural Gas Company is responsible for the completeness, accuracy and the validity of the information included in the Sustainable Bonds Use of Proceeds Report below. Management of NW Natural asserts that during the period from January 1, 2019 through June 30, 2022, an amount equivalent to or in excess of the net proceeds of \$129.0 million from the November 2021 issuance of 3.078% Sustainable First Mortgage Bonds, due 2051 (the Sustainable Bonds) has been used to finance or refinance, in part or in full, Eligible Projects in accordance with the Eligibility Criteria as defined and set forth in Note 1 to the Sustainable Bonds Use of Amounts Equivalent to Proceeds Report below.
