Dear Mr. Killip:

On September 15, 2025, Northwest Natural Gas Company, dba NW Natural (NW Natural or Company), filed tariff revisions in the above-mentioned docket with an effective date of November 1, 2025. On October 7, 2025, the Company filed to include Mist Recall capacity since our last general rate case by revising the proposed changes in the original cover letter, providing replacement tariff sheets 220.1 and 220.2, and replacing page 2 of Exhibit A.

The purpose of this filing is to remove prior Mist Recall adjustments due to those adjustments already being included in base rates. This filing now includes the 2025 incremental cost of recalling 15,000 dekatherms per day (Dth/day) of the Company's Mist storage capacity from interstate/intrastate storage customers to core utility customers. Replacement tariff sheets are provided as listed below. Exhibit A remains unchanged from the October 7, 2025 filing. Exhibit B remains unchanged from the September 15<sup>th</sup> filing.
